TITLE: DEMONITIZING OF PARAMOUNT / GAW / PARADOX CONTENT IMMEDIATELY

In light of recent comments made to "shower with your dad" and other games depicting minor children in inappropriate situations with adults to normalize sexual "digital distribution" rights of VALVE CORPORATION, a Gabe Newell company, members of the PARAMOUNT community COMICBOOK.COM L.L.C. of Nashville Tennessee engaged in active harassment to disable criticism of Newell calling such claims "bigot" remarks about adult-child sex products on the platform.

Initially reported as a "Microsoft Corporation", rather than "former Microsoft Employees", the CEO of DEEP LAYER INC. immediately issued a stop-development order for all MICROSOFT SERVER compatibility and product deployment in response to criminal threats upon the site; and to terminate by September 10th 2022 all VALVE STEAM KEYS purchased for give-away and gifts in DEEP LAYER INC. programs.

On further review afforded the September 3rd to 10th 2022 period identification of the host site of the remarks appears to be COMICBOOK.COM L.L.C., of Nashville TN – a PARAMOUNT company.

Threats and remarks in these areas, in regard to a 44 million person viewership and corporate sponsorship of COMICBOOK.COM according to their site and GOOGLE ANALYTICS, and endorsement of pedophile software and age verification fraud as a policy by VALUE CORPORATION to highly questionable content; initiated by Valve moderate decisions to ban a developer for expressing gender opinions contrary prevailing claims by Valve Corporation employees; who cited "includes insults targeting another person.." as the cause for delisting and terminating distribution based on allegations of Canadian transgender TWITCH.TV streamer "Keffals" (Clara Sorrenti).

Legal research reveals that as a consequence of false claims of voluntary removal of the game, false product reviews, and harassment permitted by VALVE, the developer has been de-platformed on TWITTER as well.

To be crystal clear:

- DEEP LAYER INC. does not tolerate financial "RIGHT TO WORK" suspension based on ARTICLE XXIII-1A violations of Oklahoma Constitution, a 10th Amendment UNITED STATES FEDERAL RIGHT.
- 2. Gender orientation and right of expression are "religious expression", protected by ARTICLE I section I-2 of the Constitution of the State of Oklahoma.
- 3. Any person engaged in PUBLIC PERFORMANCE is subject CRITICAL REVIEW which may not be predicated on their current or future employment, or to compel their manner of work or

product in design or construction to conform without construction of a FEDERAL EMPLOYMENT LABOR CONTRACT being so made for all time and costs incurred and all losses for any non-enumerated endorsed contract. Lack of a legal endorsement to TERMS does not grant a rider agreement or other contract binding force to compel or limit speech, sustain public position, or other policy of a DISTRIBUTOR of a "DIGITAL GOODS" in INTERSTATE COMMERCE or INTERNATIONAL TRADE WITH THE UNITED STATES.

- 4. While the developer is a CANADIAN CITIZEN, the sale of their goods by a UNITED STATES DISTRIBUTOR in BELLEVIEW WASHINGTON places this matter under U.S. Law.
- 5. DEEP LAYER INC. will therefore deem PARAMOUNT INTERACTIVE / PARAMOUNT+ and any derived works and performances featuring PARAMOUNT PROPERTY as "banned content" on the ZLI network subject to:
 - i.) Immediate termination of contract on first display.
 - ii.) Forfeiture of any unpaid streaming revenue or earnings or other benefits or incentives.
 - iii.) Loss of Name Registration for a period of six months per offense, requiring re-application.
 - iv.) This ban includes advertising for PARAMOUNT films, books, websites, toys, licensees, et al.

II. LEGAL NOTICE:

Civil tort (contract) may not restrict any Federal or State Constitutional Right, Per Oklahoma Constitution Article XXIII section XXIII-8 and XXIII-9, with the estate or natural person, under Oklahoma Law Title 22.

Where a company may find speech objectionable, or make requests to end relationships, it is not "for cause" at law to terminate contracts when contractors (1099m) do not perform the work in the manner that the contracting party wishes; and may only render a decision to terminate the contractor based on the delivered product rendered final. Overreach to suggest a "legal hold on 1st Amendment expression and religious convictions, suffrage, or criticism of PUBLIC FIGURES who are NOT CONTRACTORS of the same organization, is undocumented union activity prohibited by Article XXIII-1A rule.

DEEP LAYER INC. finds in this case, in agency of TWITCH INTERACTIVE INC., an AMAZON INC. subsidiary; that VALVE CORPORATION acted improperly, causing serious injuries representing antitrust activity and an abuse of the developer's remarks to a GRAMATICAL CORRECTION OF NAME IN A DEAD LANGUAGE and statements objecting to religious and theological <u>reserved rights of human beings</u> specified in <u>THE UNIVERSAL DECLARATION OF HUMAN RIGHTS</u>, a charter of rights by the United Nations members.

Where such income is the sole income of the worker, or a major portion of it, such action by a trust or multiple companies constitutes a serious infringement upon the rights of the person to <u>utterly destroy</u> their ability to obtain work, function in society, and to impair their legal form of support to compel a "suffrage right" unlawfully.

Dispute by PARAMOUNT community members to speak felony sedition against these rights in fraud and to invoke Title 43A Oklahoma Statutory Code section 43A-5-104 claims in rhetoric themed criminal threats under Oklahoma Law, affords DEEP LAYER INC. the legal right to apply a CONTENT-WIDE-BAN against all PARAMOUNT PROPERTIES effective immediately.

III. IMPACT

This decision comes in concert with 2010-2022 fraud to extort by guests appearing with LARRY NEMECEK who engaged in WHITHOLDING OF ORDERED POSSESSION OF A CHILD TO BLACKMAIL in 2013-2022 against persons in the City of Ada, Oklahoma and in concert with demands for money and property over \$80,000 USD in such threats; and in 2021-2022 new and published demands on DEEP LAYER INC. to "forfeiture" of the "RIGHT TO WORK" in anticompetitive practices on behalf of "FEARCAST", "BRIAN YOUNG", and for-profit misuse of KEIF-LP ENID RADIO resulting in \$10,000 fine by the FCC. Threats against persons to do "serious bodily harm" including sexual assault in 2013-2022, in concert with continued appearance of such persons to trade on the conduct of these persons after arrest for SMS TEXT THREAT OF MURDER of two female persons in Enid Oklahoma;

The conversion of events for minor children to "hate based events" employing historical properties like STAR TREK, that engage in ARTICLE XXIII-1A activity themed criminal and injury to children of medical record; make the remarks observed by the CEO of DEEP LAYER INC. exceptionally relevant.

AS A CONSEQUNCE, no promotion or events or products deemed to be PARAMOUNT property will be afforded access or use of the DEEP LAYER INC. NETWORK effective immediately.

This includes cosplays, uniforms of persons, shows or actors in character (though not out of character), and shall exclude those workers from any projects done outside of PARAMOUNT companies from such limitations as independent free agents entitled separation from such industry misuse of their image.

We deeply regret that actors such as Patrick Stewart and others who have worked diligently to make STAR TREK a product of acceptance, inclusion, and rational differences among cultures over many years since Gene and Majel Barrett-Roddenberry passed away.

However, DEEP LAYER INC. will not tolerate transgender "civil death" actions to cut off employment for workers on platforms that are not CONTRACTED WITH TWITCH INTERACTIVE as if their agent-at-law; nor use of CLINICAL MEDICAL CLAIMS TO INTIMIDATE AND DEFRAUD in support of minor-attracted-persons, misuse of DIGITAL DISTRIBUTION features to entice children across state lines (observed in our legal study of Twitch Interactive over 2017-2021 November 1st), or allow such properties to mix with our content and programming to any commercial benefit.

STEAM GAME KEY give-away will remain <u>suspended</u> pending investigation of HATE SPEECH by PARAMOUNT and VALVE against transgender solicitation of minors across State and Federal borders, presently a "banned activity" by any gender on DEEP LAYER INC. and its age-verified network.

AGE VERIFICATION means your children can play in peace without fear of being approached by an adult with romantic intent to entice them to communicate without permission or consent of a parent or guardian. While this is not the case, nor exclusive to trans or homosexual or heterosexual perpetrators, the danger and weakness of local, State, and Federal law enforcement in the United States makes the customer's right to choose a Structured Interactive Media Service (SIMS) over unregulated, a legal right.

Use of physical events like GENCON and DRAGONCON, and SOONERCON, to create such events, a tradition of regional works for charity in Oklahoma; to assume a franchise over STAR TREK and other properties which promote TRANS and POLY relationships before very young audiences without public

knowledge or consent, through online interactive media, and by URL resources afforded various public (TWITCH) and private (ONLYFANS) platforms; a far more unsafe and hostile environment than in the 1970s and 1980s. This change appears to be due to DEMOCRATIC PARTY DIRECT INTERVENTION and to compel and coerce criminally those persons objecting to religious and extremist events to cease participation in the regional programming, and to invite foreign representative companies from Amsterdam, Reykjavick, and Swedish firms to bring narcotics to the events in witness of our staff and before multiple contractors to solicit minors.

Based on this, and repeated narcotic and sexually themed content from PARADOX INTERACTIVE AB, GAMES WORKSHOP GROUP (LSE:GAW), and now PARAMOUNT;

DEEP LAYER INC. has banned those properties use, display, promotion, discussion, or other reference in paid or monetized broadcasting effective September 3rd 2022.

Decision to act in this degree against all firms was pending review of new evidence of piracy in 2014 and 2022 resulting in the death of persons in Pontotoc County and IDENTITY THEFT in the prior commercial fraud; and to commercial degree of appropriate response and parties at law to apply any ban or rule.

The content of all prior groups, their companies, and any employee of record of those firms based on 2013 threats in written format and 2022 threats in written format, obligate the firm to take action against the enterprise and franchise as a broad and content-oriented ban.

PARAMOUNT have their own streaming network (PARAMOUNT+), and will not be impaired by loss of this to suggest damages of any kind. GAMES WORKSHOP GROUP also has "WARHAMMER+", and such firms joint activity suggest further illicit misuse of antitrust activity that similar to TWITCH INTERACTIVE work with VALVE CORPORATION for DOTA promotions, constitute an unlawful antitrust action discriminating against small developers in the marketplace and silencing those developers by systematic de-platforming to suit the union activity and policy on transgender lifestyle promotion as normative.

DEEP LAYER INC. does not approve of transphobia, nor discriminate against transgender content creators. The firm is observing W-2 versus 1099m contract law, citing limitations in the restriction and alteration of product to conform to DISTRIBUTOR DEMANDS not permitted without W2 health insurance and benefits and other wages and job security denied to VALVE CORPORATION and TWITCH INTERACTIVE content creators. "Right of publicity" to "legally defined franchised products" is a reserved right, entitled direction of work and "fitness of purpose" for content acceptance and payment of benefits through DEEP LAYER INC. No indication or penalty for content developers expression or opinions on other platforms or public statements on other platforms will be used against their employment or benefits by our service, and are limited solely to use of the NETWORK SERVICE on this platform and its partners distribution in license.

The increasing and incorrect presumption that minor audiences can be deceived by compelling persons to conceal their opinions in representation of product or commercial services without a full W2 EMPLOYMENT BENEFITS PACKAGE commensurate with publicity both on and off the primary platform, is absurd and a violation of human rights set before and ratified by the United Nations.

Sexuality, and the expression of affinity or dis-affinity is a protected right, suffrage, and shall not be directed or compelled for "RIGHT TO WORK" in a 1099m sub-poverty-level environment by any firm permitted to carry out business, sell, or trade upon this network, by commission of the United States.
