TITLE: HATE SPEECH ESCALATES BAN

At 12:10 pm, harassment of employees to compel their acceptance of TRANSGENDER GROOMING OF MINOR CHILDREN by members of COMICBOOK.COM L.L.C. of Nashville TN, a PARAMOUNT GROUP company, was brought to our attention.

## OFFENSE

Images of penises on the account were provided showing sexually explicit content uploaded and distributed from STATE OF NEW YORK to STATE OF CALIFORNIA then served on STATE OF OKLAHOMA business owners to compel PARAMOUNT GROUP editors support of antitrust deplatforming of a developer for remarks opposed to child sex grooming by transgender members of TWITCH INTERACTIVE and on behalf of TWITCH INTERACTIVE public figures; styled as a private person falsely; to retaliate for developer opinion of misconduct targeting minor audiences.

As a result of this escalation, a formal complaint of harassment to compel LGBTQ+ themed editorial control over VALVE LLC based on hate speech and in a pattern used to deliver extortion demands in a WITHHOLDING OF ORDERED POSSESSION OF A CHILD and \$100,000 probate fraud, identity theft, and use of the domain HALIBURTON.COM to impersonate JOBS.HALLIBURTON.COM in 2022 April-July, will be relayed to PARAMOUNT GROUP Tuesday September 7<sup>th</sup> 2022.

1. **DEEP LAYER INC. will further take action to cancel all VALVE CORPORATION promotions** citing HATE CRIME community and pursuit to harass persons in sexual activity themed on minor child exploitation.
2. **No firm supporting this form of Interstate Stalking will be featured or granted platform use,** whether by group member activity of COMICBOOK.COM LLC or PARAMOUNT GROUP or STEAMPOWERED.COM.
3. **Harassment of persons to gain a favorable review, alter claims, or harm their personal relations** to promote SEXUAL ACCESS TO MINORS or simulated sexual “digital downloads” of such products made available on VALVE CORPORATION and by guests of events featuring PARAMOUNT GROUP employees in a pattern of hate crime and false police reports oriented on injury to children, support our prior decision to wholly and permanently bar these companies from future access. Failure of the moderators to respect this process or lack of tools to prohibit such organized stalking for sex trafficking by META strongly factor into our decision to employ X.509 pre-certified member access and strict guidelines for use and communication.



## **HATE CONDUCT:**

The hate conduct in this matter affirms why VAMPIREFREAKS.COM and its members, including 30,000 members self-identified as “ICP” generally reported in 2012 to be engaged in drug and criminal activity via those forums in STATE OF NEW YORK in concert with extortion letters in HUMAN TRAFFICKING and WITHHOLDING OF A CHILD FROM ORDERED POSSESSION, documented by licensed private investigation of threats by LOSTSERVER and DEPREF.NET users sustained in 2021-2022 to harass persons who died in March 2022; both before and after their death – obligate this action.

The Federal Bureau of Investigation – at that time – and in clear action not related to the official band or its promoters intent, was identified as an interstate criminal organization then in the “Insane Clown Possee” to conceal drug trafficking to minor children and disarm school officials to intensive narcotics offerings. Ultimately the site was shut down and administrators of the group confided they feared for their life due to the nature of persons attracted to the community.

Any community that encourages EXTREMISM and UNSOLICITED DIRECTED ABUSE to intimidate, coerce, or harass – does not represent a lawful business or operation.

State of New York has been on our alert community as a result of that 2013 threat-of-murder and sexual assault community organized to harass victims of brain cancer in 1999, 2001-2004, and 2007-2013.

Incidents today obligate our firm to therefore DEMONETIZE all NEW YORK STATE streamers until the DISTRICT ATTORNEY OF THE STATE OF NEW YORK can correctly address these criminal issues in their state and conduct via META and PARAMOUNT to sustain concealment of children from HABEAS CORPUS orders and recovery falsely circulated via LGBTQ and BDSM community for-profit businesses and promoters in those regions.

The use of BDSM community networking with THECHURCHBOARD.COM and other sites in STATE OF TEXAS, STATE OF CALIFORNIA, and STATE OF FLORIDA to promote these threats in concert with 2323 Bryan Street, Dallas Texas contractors for COGENT COMMUNICATIONS and NTT-VERIO (NTT GROUP); raise questions regarding the use of sex trafficking and transgender content directed by AMAZON INC. subsidiaries towards children in TWITCH INTERACTIVE SERVICES, and to retaliation by such community themed ORGANIZED VICE AND SEX WORKER INTERSTATE ENTICEMENT OF CHILDREN.

## USER ACCOUNTS:

User “Claire Lachmayer” Meta account claire.rider.7330 delivered the multiple harassing messages to DEEP LAYER INC. employees on behalf of the hate site COMICBOOK.COM LLC (PARAMOUNT GROUP) transgender community to State of Oklahoma.

Harassment of this nature is why META has become unusable for business, due flaws designed to support harassment of users and negligence of community standards including fraud and punitive retaliation tampering with U.S. elections and business regularly.

## ACTIONS:

- 4. We no longer use META or its products regularly, maintaining a presence only for initial established name despite IDENTITY THEFT tolerated by META EMPLOYEES during TAKING AND CONCEALMENT OF A CHILD FOR VIOLATION OF ORDERED POSSESSION EVIDENT IN THOSE PUBLICATIONS AND ONLINE HUMAN TRAFFICKING.**

Personal sexual choices do not entitle persons to harass others. Conversion of this to a presumed right to malign persons for contest to actions prohibited at law makes META an extremist forum, operating solely to impair human rights and damaging commercial relationships in the community systematically.

We cannot have confidence in a “Social Media” platform that encourages fraud, affords defamatory abuse, or empowers a community to promote minor-attracted persons in intimidation of parents and businesses for AMAZON INC. or TWITCH INTERACTIVE for-profit business targeting minor audiences.

From 2017-2021, DEEP LAYER INC. fully explored the potential of partnering with TWITCH.TV or YOUTUBE.COM for video services and distribution.

Our findings, confirmed by retaliation to extort and blackmail our office on notice we opted to host our content elsewhere due to minor-attracted persons and systematic fraud on those platforms paired with ONLYFANS adult content targeting minor audiences openly touted by PARTNERS of the companies.

The prior sustained abuse shows the level of International child trafficking and sex-content marketing supported by the businesses in concert with physical appearances at show events in NORMAN OKLAHOMA, MIDWEST CITY OKLAHOMA, TULSA OKLAHOMA, DALLAS TEXAS and using comic book conventions DRAGONCON and GENCON to approach new underage audiences to this franchise.

***It is our deep and sincere belief that PARAMOUNT GROUP and the owners of the original STAR TREK property did not intend for their content to be used by SEXUALLY THEMED CONTENT INDUSTRIES, or afford sexual adaptations of their property into actual sexual service companies who predicate their business on the generally underage audiences attracted to their product for good value and good character.***

It is not enough to call criticism of such monetization of minor audience platforms like CLUB PENGUIN or TWITCH.TV or adult-disclaimer content on VALVE LLC to be “bigotry” against the improper and organized commercial approach of MINOR CHILDREN under “comics” and “games” titles.

***Especially where performers are public about bragging their earnings are over \$1+ million USD for homosexual relationship performances and publishing “lap dance” and “stripper pole” instruction videos on YOUTUBE at the same time and in full awareness the audience are mostly under 18 years of age.***

**PRIOR NIGHTCLUB CONVERSION VIRTUALLY TOWARD MINORS:**

Club activity of 18+ venues in DALLAS TEXAS like THE LIZARD LOUNGE gave rise to this adult content, but its commercial monetization to younger audiences by NEW YORK STATE websites targeting minors themed to be a competitor with HOT TOPIC and aimed at similar underage audiences;

With private rooms and video chat predating DISCORD, fail to exercise the same basic controls and safeguards necessary while preying on a public whose law enforcement regard the exploitation of children to be a PARENTAL SUPERVISION issue rather than an organized multi-million Dollar business approaching children at real-life events through accepted toys, characters, and “cosplay” – and conversion of such hobby to sexual performance on META platforms “INSTAGRAM” a major shift in use of the platform widely acknowledged and commercially “endorsed” by META to deliver adult erotic content to minors.

**CONCERN AT SITE POLICY TO TRAFFICKING:**

The “Don’t ask don’t tell” policy does not protect minors, and efforts to approach children in parent-child relationships and for modelling behavior of sexual stereotypes without consent of both parents; employing defects in custody and court orders – supports concerns of real parents including over 200,000 per year who lose ALL CONTACT with their child permanently and without legal cause due to the fraud in family courts and FEDERAL REGISTER VOLUME 81 NUMBER 244 non-compliance by States including Texas, Oklahoma, and other kidnap-to-custody and sex-trafficking-export ports.

We have been observing the CALIFORNIA to Amsterdam connection of TWITCH INTERACTIVE in concert with threats from COGENT COMMUNICATIONS and atlas.cogentco.com in Copenhagen; and have reasonable cause to believe that a foreign commercial interest in such children and in travel and misuse of publicity to encourage travel and foreign “sex tourism” activity is a component of this commercial fraud initially reported at INFOMART and 2323 Bryan Street in 2002 and 2011 letters of threat in child concealment to extort.

**PARAMOUNT GROUP has legal interest in promoting its properties in publications and events, including comic books and other merchandise.**

However, when its community becomes enjoined with TRANSGENDER sexual advocacy in ONTARIO CANADA or punitive actions to demonetize persons for dispute with “approach of children to sexually entice them to undertake medical or psychological therapy without a MEDICAL LICENSE”, and such practices are cited by PEOPLE’S REPUBLIC OF CHINA as illicit activity outside the commercial rights of entertainment in digital video and to minor audiences;

Those concerns seem excessive without respect to VIOLENT AND CRIMINAL HUMAN TRAFFICKING WITH CHILD INJURY AND MISSING PERSONS BARRED BY FEDERAL LAW who commercially gather under the color of “safe space” and “protected forums” to organized and then execute hate crimes and stalk persons in an effort to criminally silence witnesses, intimidate other companies, and under franchise of the license and legacy of GENE RODDENBARRY and MAJEL RODDENBARRY.



**RESPECTED COMMUNITIES IMPACTED:**

Members of the Star Trek community, informed of these issues, and with respect to VIOLATION OF ORDERED POSSESSION have continued to appear and endorse proponents of this fraud activity in Oklahoma, damaging permanently any relationship whatsoever with PARAMOUNT or its subsidiaries.

While *guests may not be responsible to these issues, they do represent brand ambassadors in the capacity of PARAMOUNT EMPLOYEES*, just as publicity companies (COMICBOOK.COM LLC) represents PARAMOUNT GROUP in its decision to discredit and harass a game developer for remarks OUTSIDE OF CONTRACT TERMS FOR HIS DISTRIBUTOR, TO ALTER THE REVIEW OF A PUBLIC FIGURE, AND TO INTIMIDATE POLITICAL SUFFRAGE RIGHTS BY MARKET ACCESS DENIAL TO RELIGIOUS GROUPS based on nothing more than objective criticism.

- 5. PARAMOUNT GROUP should recognize these are HATE CRIMES of a religious significance;** component to a pattern of injury to children and interference with INTERSTATE COMMERCE activity using their product line to promote injury to parental rights and children themed “child abuse” in the DSM-V and Federal Law; and to take action to limit these “sex positive” “minor-attracted” and “adult-minor-interaction” lobbies before FEDERAL REGULATORY ACTION IS NECESSARY IN ANTITRUST ACTION.

Contract law to suggest portions of the Oklahoma State Constitution and Article XXIII-8 and XXIII-9 are void, and rights may be suspended by “TERMS OF SERVICE” or other tort, promoted as a seditious felony and aggravated perjury popularized by BDSM and human trafficking communities false claims and waiver para-legal practices indemnifying themselves from bodily injury and health conditions arising from sex services, appear central to such harassment SEPTEMBER 4<sup>th</sup> 2022, and part of COMICBOOK.COM LLC claims to harass members in aggravated perjury on behalf of META, AMAZON INC., and TWITCH.TV subcontractors engaged in dual employment activity as sex workers.

### **CRITICAL TEST OF HARASSMENT:**

DEEP LAYER must regard this conduct, paired with “additional contact” following after midnight September 4<sup>th</sup> 2022 as HARASSMENT by PARAMOUNT GROUP members via META services – to coerce and cause commercial harm in a pattern of “18 U.S. Code section 249 HATE CRIME activity” and fraud.

Prior conduct November 7<sup>th</sup> and 14<sup>th</sup> and January 28<sup>th</sup> and 30<sup>th</sup> and April 4<sup>th</sup> and May 13<sup>th</sup> in concert with FEDERAL CRIMINAL USE OF U.S. MAIL to make demands violating FEDERAL REGISTER and United States Public Policy in UNITED STATES DEPARTMENT OF HEALTH AND HUMAN SERVICES exclusive, limited, and delegated authority prohibited as UNCONSTITUTIONAL 4<sup>th</sup> and 14<sup>th</sup> Amendment criminal activity; make the renewed communication from the community to this abuse component in “just cause” to impose a perpetual and franchise-wide ban on all PARAMOUNT GROUP products and employees, promotions, events, and commercial bidding.

### **HISTORICAL PARALLELS IN PRIOR HATE GROUPS:**

National Socialists used comic books and sexual liberty to inspire and draw upon public support and confidence in the prior Century, in Germany.

These same tactics and association with COMIC BOOK and media and interactive video, to style persons as mentally inferior, as drug users, and as incapable and incompetent – are direct adaptation of tactics promoting similar “democratic” movements to overcome the privacy and protection of persons in their publications, in their community, and to harass them in their business and personal relations.

While it is our belief that neither Gene Roddenberry or his original cast would have accepted such conduct, those persons are dead. Other gatekeepers appear less committed to the dangers and experience that James Doohan and his veterans knew full well in experience off-screen facing these same “right think” ideas.

Where Star Trek or its parent company becomes a symbol for those “coercive forces” to compel American businesses to rally behind rather than avoid; or such company mistakes inclusion for a “RIGHT TO ACCESS MARKETS BASED ON ENDORSEMENT OF OTHER PERSONS IN THEIR WORK” barred by Oklahoma Constitution Article XXIII-1A as criminal – antitrust must be considered and the role of such franchises to harm, suppress, or dilute the claims of victims of organized violence and human trafficking as inferior to “commercial interest” of the studio – substantive legal basis for new HAYS CODE to curb those representations based on UNITED STATES REGIONAL DISTRIBUTION RIGHTS and UNITED STATES COMMISSION AND HIRING RIGHTS, rather than existing media delivery and public versus private channels of mass communication afforded by “digital goods” and services in registered property.



If “digital goods” and “private in-home delivery” have created a shelter for large scale and INTERSTATE ORGANIZED CHILD SEX TRAFFICKING AND INTERSTATE SEX WORKER EXPLOITATION OF SUCH PRODUCTS AND EVENTS themed to be “child friendly” and “politically open marketplaces of ideas” – as META has expressed and promoted in violation of 47 U.S. Code section 230, to editorialize as false in “aggravated felony perjury” claims of evidence to influence a U.S. Election process and intimidate candidates systematically in organized criminal and union racketeering under false name; enticing PARAMOUNT GROUP and AMAZON INC. to enjoin this process in a trust activity against POLITICAL AND PROTECTED SPEECH and report of criminal activity – Legislative action to modify the laws to clarify “forfeiture and delisting of publicly traded securities” to penalize those firms by suspension and permanently disbarment of claims into the public domain for all members of the market to use, or similar penalty for interference in the access to FREE MARKETS barred by such misuse of the franchise is necessary.

Prior we assumed HULU and NETFLIX provided sufficient counter to these concerns; that PARAMOUNT or AMAZON would not enter into foreign digital hosting and transport agreements sufficient to impact competition. Disney Corporation now owns Hulu, and Netflix Inc. is expressing its own extreme position, in concert with its provider COGENT COMMUNICATIONS INC., leaving many customers wishing for alternative market options in traditional conservative media which is rapidly disappearing in AMAZON and PARAMOUNT catalogs ongoing changes to expand into adult markets.

With TENCENT MEDIA as the only comparable competitor – this raises the question as to whether antitrust investigations into sexual content targeting minors should be addressed in the United States as it has been in PEOPLE’S REPUBLIC OF CHINA in 2022.

### **MERGERS AND ACQUISITIONS:**

As DARK HORSE COMICS, originally a domestic adult oriented media house, and other properties are shifting to ownership by NORDIC GAMES GROUP (THQQF) headquartered in Vienna Austria and originating in Sweden, we find a nexus of product and commercial franchise activity with PARADOX INTERACTIVE AB and other developers cited in 2013 extortion letters in WITHHOLDING OF ORDERED POSSESSION OF A CHILD, which again begs the question of HUMAN TRAFFICKING relationships to sexual content and attitudes on child welfare in Sweden, Austria, Iceland, and foreign countries with a history of racial prejudice and discrimination operating in the same sectors – whereby transgender and same-sex characters use and sales value in frequency far exceeds that of ordinary public gender representation.

Every company is struggling to “play the inclusion card” for extra audience boosts and social justice popularized in the reform of past prejudice. There is injustice to be certain.

But when such abuse is exclusive of ORDERED POSSESSION OF CHILDREN and to support HATE CRIME activity among fan communities against heterosexual fans, Christian and Muslim parents, and to demean and abuse them for their views as if their children “belong to society” and “are victims of their parent’s culture” – borders on sheer nazi extremism.

### **LETTERS OF THREAT RECEIVED BY OUR OFFICE:**

It is the same thing as degrading parents of “disabled persons” in Germany, during the executions of such children and adult dependents, as eugenic threats and a public health hazard whose right to breed was conditioned to the acceptance of a lesser role in society than “pure Aryan” ideals.

Our company visit to “COMICBOOK.COM LLC” left our staff feeling like we had just visited a Nazi Rally.

The impression was that of hate, organized degrading of a person, and of anyone who defended him.

After leaving, we were followed and harassed on our own pages for having spoken about the matter.

This conduct went on for four hours; and was initiated by your staff calling for the abuse of persons who did not endorse TRANSGENDER PERFORMERS APPROACH OF MINOR AUDIENCES.

After going to dozens of these events, only the recent Oklahoma and Texas shows in 2010 even hinted at this level of hostility and violence, following performers to their homes and taking photos of those homes in an effort to force the sale of real estate in abuse of an Alzheimer’s Patient on concealment of her only grandchild.

PARAMOUNT GROUP must therefore consider if this is the new face of STAR TREK.

### **ACTIONS BY DEEP LAYER AS POLICY:**

Our company will consider the conduct of COMICBOOK.COM LLC users as representative of that and other PARAMOUNT BRANDS, and as usual we find SWEDISH and AUSTRIAN ownership of the companies that once represented vested cornerstones in our confidence in such socially positive fiction and works to be now owned and operated by groups who are broadly recognized in other works as fundamentally racist, responsible for the rape of other countries civilians as targets of seafaring slavery, and returning to those old customs in economic development of products targeting children and glorifying transgender occult sexual and violent mythology with prior Century eugenic undertones and class based ethnic fiction romanticizing medieval practices of European colonization and expansionism.

Where Star Trek once represented the coming together of people from different worlds, it now appears to constitute a different struggle of demonizing military and diverse cultures who do not see relationships the same way that the majority of the collective society and their popular opinion do.

Dehumanizing some masculine characters, while promoting voluntary suicide for others, and promoting genetic augmentation as a “rational future” to improve the human race – one can hardly recognize the property or the characters anymore. Blaming a child without guidance and parents for “The Burn”, to suggest the need for societal guidance to overcome franchise and provide structure, is no less nazi-oriented than the portrayal of installing homosexual parental role models and adult-child romantic relationships in recent Star Trek franchise works. Despite this, viewers were optimistic higher production value in Undiscovered Worlds would resume the course under experienced well developed prequel timelines with solid actors.

The whole process looks like a “trope”, pandering to a community that is zealous with hatred for a community that makes up the majority of fans.

To parents, whose children are being solicited in school and at work to participate in such normalized removal of both parents without LEGAL CAUSE, and in concealment to abuse and injure children while placing the blame on failure to participate in the workforce in inferior positions to illegal trust activity and fraud on a very large scale targeting minors and investors; it is unnerving.

But like Disney Corporation, public audiences had no idea what sort of conduct off-screen was occurring to normalize these performances; or that executives were exercising direct control to assure these foreign values and anti-family narratives were being enabled to gain acceptance of loss of normal family and substitution of that bond with employment, utility, and relationships of convenience.

This is not just a moral attack on the American family as an ideal.

It is a legal attack on the children and public trust to enforce obligations required by United States Law and Federal Public Policy; which preclude discrimination on the basis of gender, and do so without consideration that men are “lesser” parents for their reproductive role or “greater” debtors for their traditional workforce and military duty, to the exclusion of their franchise to enjoy or contribute to the upbringing, instruction, and enjoy a bond with their children. These roles are real prejudice and are not entitled license per THE UNIVERSAL DECLARATION OF HUMAN RIGHTS or other legal or religious theory at law, and it is old-nazi-socialism returned in the “mothers have a superior right” claims to suggest the state and the mother assume control of the child and its instruction, until the father produce his “harvest” to earn that privilege.

**IMPRESSION MADE BY COMICBOOK.COM LLC:**

This impression, in TRANSGENDER roles and market access, is what we took away from COMICBOOK.COM LLC members Saturday. That the community has a sexually deviant position over child development which the PARAMOUNT GROUP employees in Nashville TN endorsed and supported; and were engaged in hate crime activity upon META services that the company has become known for.

With this in mind, and without respect to the civil rights of LGBTQ persons to protection at law and from violence and other forms of genuine discrimination not arising from improper conduct any employee would be subject correction;

DEEP LAYER INC. finds qualified cause to terminate all payment to promoters of the prior brands following harassment and communication to menace after midnight the company for its assessment of commercial harm to minor children.

NVIDIA CORPORATION, PARAMOUNT GROUP, DARK HORSE, and other companies representing works of national character and history, should not be sold outside the United States and such sale of stock to persons foreign to the origin and interests of those firms appears to have altered and encouraged incitement of violence against persons by class and with contempt for the Constitutional protections of the State of Oklahoma and United States minimum protections; undermining confidence in the national Public Trust and its administration of business and minimum standards to maintain a safe environment for all Americans regardless of religious and political views.

Minor attracted adult behavior in this country IS NOT a political view, and barred at law, as is sexual performance for minor audiences and sexual favors for money across State Lines prohibited platforms that exempt a PUBLIC FIGURE regardless of their gender or sexual orientation from criticism, or to enjoin persons to cease or alter such criticism on fear of loss of employment or other access to market for views contrary those of PARAMOUNT.

DEEP LAYER INC. holds PARAMOUNT GROUP legally responsible for the editorial language in COMICBOOK.COM LLC as derogatory and defamatory, commercially harmful, and a hate speech act. Such act appears to be a concerted effort to aid VALVE CORPORATION and DOTA developer in illegal trust activity, to smear a competitor and remove them from market in our professional finding.

DEEP LAYER INC. will report these concerns to the FEDERAL TRADE COMMISSION in request for ANTITRUST INVESTIGATION OF PARAMOUNT-AMAZON activity in formal complaint, based on this additional "following, harassment, and explicit intimidation activity" following the prior contact.

We elected to launch a private service because this misuse of service and lack of moderation is foreseeable in present META and interactive "social media" abuse; and ultimately gives voice to elements on the official forum of the product seen as endorsement when not removed quickly; to civil unrest and political and commercial impairment of the Public Trust and Peace.

### **EXCESSIVE THREATS AND ABUSE:**

Ordinary people don't message others 50 times in the middle of the night to harass them while they are sick with COVID-19, caring for a dying parent, or tending to an injured animal harmed by felony animal cruelty in related vandalism and hate crimes. Companies relying on this sort of "support", should be aware the impact from "serious bodily harm" and "real injury" to "real persons and children" leave lifelong resentment that is beyond the scope of their limited franchise to publish works of fiction for entertainment, and represent development of commercial "hunt groups" with anti-competitive activity.

Your viewership's failure to register "adult-child-simulated-nudity" as inappropriate and to support the "SHOWER WITH YOUR DAD SIMULATOR" while berating a person for asking public media performers to not counsel children on sexual decisions regarding their mental health over TWITCH.TV substantially undermines the STEAMPOWERED.COM moderator decision to remove the title and falsify the cause for removal of a COMMERCIAL PRODUCT FROM MARKET TERMINATING REVENUE AND ADVERTISING SPENDS ALREADY IN PLACE, based on prejudice in the transgender community to normalize such things.

Paramount Group companies were once a high standard in media. They represented safety and confidence. Since 2010, their brand has instead represented exclusion and child abuse to our firm. We were not fully aware of the origin of the claims to connect the two company acts in endorsement of such fraud and WITHHOLDING OF ORDERED POSSESSION OF A CHILD in 2010-2015, but research shows now that the company owns the platform publishing the review and it is the company subscribers who published hate speech to our employees to harass them further in this matter over 4 hours.

### **SANCTIONS WILL BE AMENDED**

Therefore, Sanctions will be amended to terminate VALVE CORPORATION and finalized from our vendor and promoter list. A Federal Trade Commission Complaint of organized harassment activity on transgender content will be filed. Use of threats in identical fashion to those employed aiding in the death of an Oklahoma pediatrician and her identity theft will further be incorporated with that Federal Trade Commission complaint as a franchise activity prior seen at events in Oklahoma related arrest on threat of murder and sustained PARAMOUNT GROUP employee appearances endorsing those persons harassment and child concealment conduct with threats against disabled persons in 2010, 2013, and 2022.

No contact will be permitted with PARAMOUNT GROUP, COMICBOOK.COM LLC, and all such communications not through the court or FEDERAL TRADE COMMISSION will be construed as harassment.

This order will be deemed permanent, due to the wrongful death and Federal Identity Theft involving TRANSGENDER misrepresentation by PARAMOUNT GROUP promoters and commercial licensees in Norman, Oklahoma; paired with September 4<sup>th</sup> 2022 renewed threats via META platforms in identical fashion to extort and molest witnesses and private persons for their participation in false characterization of a WRONGFUL TERMINATION as at-fault, in fraud there admitted, and in inter-company punitive retaliation for a competitive company ("Valve Corporation") and product ("Dota") themed a special interest of the company bringing suspension of DISTRIBUTION RIGHTS due to illegal trust and to coerce a public review of a PUBLIC FIGURE concerning inappropriate contact with minor children barred by Medical License.

**FUTURE INQUEST PLAN:**

We are concerned by the discovery – and will expand our investigation to DARK HORSE and other products and events, for similar nexus with countries engaged in piracy of our products and clients named in the WITHHOLDING OF ORDERED POSSESSION and child abuse under prior complaint entitled FEDERAL REGISTER and \$40 billion qui tam complaint filed July 2021.
